The Board's Caseload: The Board's caseload continues to grow. In April, the Board will review 79 cases. The Board and the Board's liaison will continue to advocate that DoA and DSS guardianship cases be reviewed separately by two Boards. The current process is not sustainable. A copy of the Board's April agenda will be sent to both the DoA and DSS Directors as well as the County Executive's Office.

File Review Results – The Board unanimously agreed to continue 28 cases.

Hearing Minutes: 53 Cases/25 Reg./28 F.R. (2 Reg. cases were postponed)

The Board heard 25 cases as full reviews with social workers and court-appointed attorneys for the client in attendance presenting the case virtually.

The Board reviewed and voted on 28 cases as file reviews. This type of review requires the guardianship client to be medically stable and in their living arrangements for at least a year. The client's social worker and attorney are not required to be present unless a full review is requested either by the Board, the client, the social worker, or the courtappointed attorney.
